## VOTING BY PROXY

If you are unable to attend the Annual Members Meeting and want to vote by proxy, please note the following information about proxies:

1. A proxy is for the purpose of appointing another person to vote for you in the event you might not be able to attend the meeting. It must be signed by the person authorized to cast the vote for the parcel/lot. If you want to vote and do not attend the Annual Meeting, you may choose to vote by proxy.
2. The proxy should be submitted to the Association prior to the scheduled time of meeting. It can be hand-delivered, either by you or your proxy, or submitted to our management company by US mail, email or fax:
